2. Persons responsible train concerning: To expertise (technology, product knowledge, measures), abilities (service, contact with angry customers), settings (criticism as a chance understands)

- 3. Provide technology: electric data processing programs, phone hotline
- 4. Create mistake culture
- 5. Quick react A complaint should be worked on within three days.

6. Personally react – no impersonal standard answer and already no answering machine. The complaint should be accepted personally and be treated individually.

7. Creatively react – Every complaint offers the chance to surprise the customer positively – with an unusual excuse or original reparation.

STEP 4 – testing of the product and examination of his conformance (risk assessment, conformance assessment)

The Ce- marking is a main indicator for the conformance of a product with the valid juridical regulations of the EU and allows the free movement of goods within the European market.. By the fixing of the CE – marking if the manufacturer confirms in own responsibility that the product fulfils all conditions which are prescribed for the CE marking legally, and guarantees with the fact that the product within the European economic area (EEA, Iceland, Norway encloses 27 member states of the EU and the EFTA's member countries and Liechtenstein) as well as in Turkey may be sold. This is also valid for products which are produced in third countries and are sold within EEA and Turkey.

It is defeated by the responsibility of the manufacturer to carry out the conformance check, to put together the technical accompanying documents, to issue the EU-conformance explanation and to attach the CE - marking in the product. Distributors of a product must check whether the CE- marking and the accompanying documentation exist.

If the product from a third country is imported, it is incumbent upon the importer to make sure that the manufacturer has taken all necessary steps beyond the EU and the documentation on inquiry can be seen
